Payment

First and foremost, please remember; childcare fees are based on a reserved space, NOT ATTENDANCE. To maintain a reserved space, fees must be paid during your child's absence due to illness, holidays, vacation, or any other reason unless otherwise agreed upon.

Payment is due EVERY FRIDAY, any payments made after Friday will be considered late & late fees will be charged.

Absences: Childcare fees are based on a reserved space, NOT ATTENDANCE. To maintain a reserved space, fees must be paid during your child's absence due to illness, holidays, vacation, or any other reason.

Lateness

Day Care ends strictly at 6:00PM, however, we understand that unforeseen circumstances/ emergencies may prevent you from picking up your child on time; we ask that you try to call ahead if such thing occurs or that you resort to the emergency contacts listed on the Enrollment Form, and have someone else pick up your child.

Late fees will be charged depending on how much time has passed after closing. They must be paid in cash. *Routine tardiness may be grounds for termination.*

Health/ Illness

Under no circumstances may a parent bring a sick child to daycare, if the child shows any signs of illness, or is unable to participate in the normal routine and regular day care program; that child will need to be picked up. If you are not sure whether or not it is okay to bring your child, please call ahead to ask us. To protect your child and the health of other children, we reserve the right to determine when a child is too ill to be cared for in our day care.

We may apply over-the-counter topical ointments, sunscreen lotion and topical insect repellent with written permission from the parent or guardian.

We are **NOT** authorized to administer any medication to a child unless one of the following occurs:

Parent/ Guardian arrives at daycare requesting medication to be given but does not have written instructions and/or permission from the authorized prescriber.

· A child develops symptoms while in our care that require the administration of an over-the-counter medication

...in which case the proper form MUST be completed.

Updated Paperwork

There are several forms that make up our enrollment packet. This packet must be completed and, in our possession, before we can assume the responsibility of caring for your child. This is to ensure that your child will get the very best care possible and the record keeping guidelines required by the state licensing agency are met. All forms will be updated annually.

MEDICATION/ EMERGENCY MEDICAL TREATMENT

- · Our inability to meet the child's needs

This contract expires exactly one year from the date signed. At this time, it will be void and a new contract will have to be signed for continued care. It can be terminated by either party provided a 1–2-week notice is given. Fees may vary at the beginning of another contract year.
